You are responsible for immediately reporting to KT if your Thredbo 365 Pass is lost, stolen or damaged by reporting the circumstances to any Thredbo Lift Pass Office or calling (02) 6459 4151 during business hours. In these circumstances or if you forget to bring your Thredbo 365 Pass you can visit a Thredbo Lift Pass Office where, upon presentation of valid ID, our staff can reissue your Thredbo 365 Pass at the cost of \$5.00 per reissue.
- 10. Thredbo reserves the right to change the terms and conditions applying to the Thredbo 365 Pass. Notification of changes to terms and conditions will be made to all Thredbo 365 Pass Holders via the Thredbo website www.thredbo.com.au, where the current version of the terms and conditions may be viewed at any time.
- 11. You acknowledge that you will observe the Alpine Responsibility Code as set out on the rear of this application and conduct yourself in a safe and controlled manner at all times.
- 12. You must read all signs and follow directions given by us, our employees and agents.

- 13. You acknowledge that the risks associated with snow based recreational activities are not always prominent, conspicuous or physically observable.

 - activity, form of behaviour, course of conduct or state of affairs in relation to an individual:
 - i) that is or may be harmful or disadvantageous to an individual or community; or
 - ii) that may result in harm or disadvantage to an individual or community,
- arising out of any failure by us, our employees or agents to comply with any consumer guarantees applying to the services.
 16. We make no warranties in relation to the services to be provided. Without limiting paragraph 14 above, all warranties, representations or conditions relating to the services we provide (whether express or implied and whether arising out of contract at common law or under statute) are to the maximum extent permitted by law expressly excluded and you acknowledge that our liability under any statutory right or any condition or warranty implied by the Competition and Consumer Act 2010 which cannot be excluded, is limited at our option to the resupply of the services or the payment of the cost of having the services supplied again.
