

Kosciuszko Thredbo Pty Ltd has prepared a Pollution Incident Response Management Plan for the Thredbo Sewage Treatment Works in accordance with NSW EPA Guidelines. This plan ensures Thredbo takes proactive steps to prevent pollution incidents and responds appropriately if an event does occur.

## Notification Procedure

If an incident occurs and it is determined that it has the potential to cause material harm to the environment, Kosciuszko Thredbo Pty Ltd will immediately contact each authority below where appropriate.

As the Plan relates to the sewerage system throughout Thredbo Village any affected community members will also be notified. Depending on the circumstances of the incident the following mechanisms will be adopted to notify and update relevant community stakeholders.

- Local media sources;
- Kosciuszko Thredbo Pty Ltd web page updates and media releases;
- E-mails;
- Telephone calls and / or door knocking (where appropriate).

Community stakeholders that will be considered include, but are not limited to: resort guests and staff, campers, fishermen, farmers, Lake Crackenback Resort, Perisher Ski Tube, NSW Department of Primary Industries (Gaden Hatchery) and Snowy Monaro Regional Council. Following any given pollution event the scale and location of the incident will dictate the stakeholders to be notified according to the Kosciuszko Thredbo's Incident Notification Protocol.

Specific actions taken by Kosciuszko Thredbo Pty Ltd, to combat the emergency will be guided by the Pollution Incident Response Management Plan and context of the emergency.
