

Thredbo Vertical Challenge Promotion - 2024

Terms & Conditions of Entry

1. Information on how to enter forms part of these conditions of entry. Entry is only open to residents of Australia and whose entry is deemed valid and accepted by Kosciuszko Thredbo ("Eligible Entrants"). Entrants must be over the age of 18 years to enter the promotion.
2. The competition commences at 12.01pm (Sydney time) on 12/07/24 and closes at 11.59pm (Sydney time) on 04/09/24 ("Promotion Period").
3. To enter participants must have skied 5,000 or more vertical meters in Thredbo in a single day and have a MyThredbo Card with a valid email address and mobile phone number on file during the Promotion Period. For details on how to purchase a MyThredbo Card and check / update your details visit thredbo.com.au/mythredbo Entrants will be automatically entered in the draw when they have skied or snowboarded over 5,000 vertical meters or more at Thredbo Resort on one single day as calculated by the pass scanners on each chairlift during the Promotion Period ("Eligible Entry"). If an entry is found to be invalid, the entrant will not be eligible to win the Prize.
4. Employees of Thredbo and their immediate family are not eligible to participate.
5. No responsibility will be taken by the Promoter for any ineligible or lost entries or entries submitted or received by the Promoter after the closing date. Entries that do not comply with these terms and conditions, are incomplete, or submitted or received by the Promoter after the closing date will be declared void.
